Review and approval of absentee ballots

Deputy Director Owen presented the board with the attached list of absentee applications to consider and approve. Secretary McMinn made the motion to approve 17 civilian absentee applications, 1 military absentee application. The motion unanimously passed.

Review and approval of previous minutes

Secretary McMinn made a motion to approve the minutes from the May 7, 2020 and May 19, 2020 board meeting. The motion carried unanimously.

Precinct official appointments

Director Storey provided the board with a list of workers needing appointments and the remaining needs for Election Day. Ms. Dashiell moved to appoint the precinct officials as presented in Brevard #1, Brevard #2, Brevard #4, Little River, and Williamson Creek. The motion passed unanimously.

DIRECTOR UPDATES

Director Storey briefed the board on early voting starting Thursday. Jacolyn Campbell and Jeanne Smith will be trained tomorrow and will work for the three week period. COVID-19 supplies are in place and workers will wear masks in the lobby. The director indicated he and staff met with Library Director Rishara Finsel to discuss and assess using the Rogow room for early voting in November. Director Storey mentioned the soil and water filing period begins June 8, 2020 and runs through July 6, 2020. The board was informed that Jake Dalton was nominated by the Republican party to fill the vacant county commissioner seat for the interim and has filed to be on the ballot in November. The Democratic party will nominate someone later this summer. Director Storey mentioned there is not a statutory deadline but

recommended the nominee file before the end of July due to administrative and logistical timelines.

Board Comments

Mr. McMinn asked about combining precincts in November to address a potential shortage of precinct workers. The director indicated the State Board of Elections will be reluctant to approve combining precincts based solely on worker shortages. In addition, a legislative bill to address COVID-19 concerns is still pending.

On a motion by Chair Champion, the meeting was adjourned at 5:57 pm. The next scheduled meeting will be at 5 pm on June 9, 2020, at 150 South Gaston Street, Brevard, NC 28712.
