Absentee Ballots

Deputy Director Owen presented the board with 1,740 CIV (civilian) absentee applications to consider and approve. The board split into two teams to review the absentee ballot envelopes. Teams consisted of Mr. Morrow (R) and Mr. McMinn (D) and the other team Chair Champion (D) and Ms. Dashiell (R). Absentee envelopes were provided sequentially by how they appear on the CIV absentee list. The following is a breakdown of who approved each page on the list.

Chair Champion made the motion to approve page 1, 4, 10, 13, 18, 29, 32, 34, 38, 41, 47. The motion passed unanimously. Ms. Dashiell made the motion to approve pages 6, 8, 15, 20, 24, 36, 44. The motion passed unanimously.

Page 2, 3, 5, 7, 9, 11, 12, 14, 16, 17, 19, 21, 22, 23, 25, 26, 28, 30, 31, 33, 35, 37, 39, 40, 42, 43, 45, 46, 48 were reviewed by Mr. Morrow and Secretary McMinn.

Secretary McMinn made the motion to approve page 2, 3, 5, 11, 12, 16, 19, 21, 25, 26, 31, 35, 39, 42, 45, 48. The motion passed unanimously. Mr. Morrow made the motion to approve page 7, 9, 14, 17, 22, 23, 28, 30, 33, 37, 40, 43, 46. The motion passed unanimously.

1,672 CIV (civilian) ballots were approved by the board. 48 ballots were held until the next meeting due that required duplication. 20 ballots require a cure certification letter or were spoiled and reissued due to CIV number on envelope not matching CIV number on ballot.
