## **Absentee Ballots**

Deputy Director Owen presented the board with 267 civilians, 17 overseas and 3 military absentee applications to consider and approve. Absentee envelopes were provided sequentially by how they appear on the CIV absentee list. The following is a breakdown of who approved each page on the list.

Page 2, 4, 5, and 7 were reviewed by Mr. Morrow and Secretary McMinn. Secretary McMinn made the motion to approve page 2, 4 and 7. Mr. Morrow made the motion to approve page 5.

Page 1, 3, 6 and 8 were reviewed by Mrs. Dashiell and Mr. Wainwright. Ms. Dashiell made the motion to approve page 1, 3, 6 and Mr. Wainwright made the motion to approve page 8.

Overseas and military absentee ballot envelopes were reviewed by all board members. One OVR was spoiled because part of the ballot was missing on the page. The ballot will be reissued.

One Stop Applications: The board considered 3,611 one stop applications from October 15, 2020 through October 17, 2020. Chair Champion made a motion to approve the list as presented. The motion passed unanimously.
