# Review and Approval of Agenda

Chair Champion asked for a review of the agenda. There were no amendments to the agenda. Secretary McMinn made a motion to approve the agenda. The motion carried unanimously.

# Review and Count of Provisional Ballots

Deputy Director Owen provided the board with 27 provisional ballot applications. Reasons with 5 incorrect party, 7 incorrect precinct, and 3 unreported moves were recommended for approval. Reasons with 8 incorrect party, 2 no record of registration, and 2 previously removed were not recommended for approval with research and explanations provided. Deputy Director Owen presented the research to the board for each category. The board held discussions over each category before determining the disposition of the ballot applications. **Member Watson made a motion to approve the 15 provisional applications as presented by staff. The motion unanimously passed.** The Board processed the 15 provisional ballots. There were 15 approved, and 12 not approved.

# Supplemental Absentee Ballots

Deputy Director Owen presented the board with the attached list of supplemental absentee applications to consider and approve. There were 13 CIV, and 1 MIL absentee ballots received by the deadline with proper postmarks. Secretary McMinn made the motion to approve 13 civilian absentee applications, and 1 military application. The motion unanimously carried.

The director provided the board with an overview of the canvassing process for tomorrow's meeting where voter history, ballot and vote reconciliations will be presented before certifying the election results.
