Review and Approval of Agenda

Secretary McMinn (D) and Member Warwick (R) reviewed the 1 OVR application. Secretary McMinn made the motion to approve page 1 or 1. The motion carried unanimously.

Director Storey informed the board there are 3,072 absentee one stop applications that have processed between November 1, 2022 and November 5, 2022. **Member West made a motion to approve the applications as presented. The motion carried unanimously.**

The director provided the board with the final lists of observers submitted by the local parties for their review.

Director Storey stated the next course of action for Election Day will be processing the absentee ballots at 2 p.m. per the previous resolution signed by the board. Results will be tabulated and remain confidential until released at 7:30 p.m. or such time the polls are closed, if extended.
