#### Review and Approval of Agenda

#### Review and Approval of Received Absentee Ballots

Deputy Director Owen presented the board with 28 CIV, 1 curable CIV, and 8 OVR absentee applications to consider and approve. Absentee envelopes were provided sequentially by how they appeared on the absentee list. Member Warwick made a motion to approve the curable civilian absentee application and add to the civilian application totals. Member West made a motion to approve the 8 overseas absentee requests. Member Walker made the motion to approve the 29 executed supplemental absentee applications. All motions were carried 4-0. Results were recorded on the official supplemental absentee abstracts.

## Review and Approval of Provisional Applications and Ballots

Deputy Director Owen presented the board with the provisional voting report and 153 provisional ballots to consider and approve. After board consideration, Member West made a motion to approve 73 of the 153 provisional ballots as presented. The motion carried unanimously.
